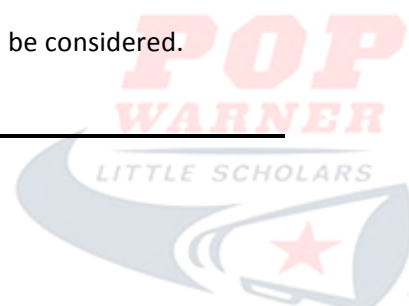
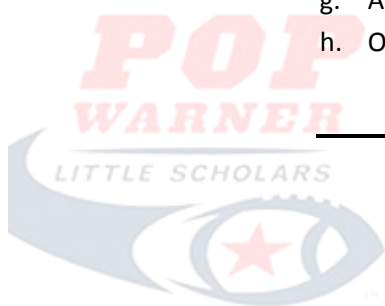


I. **Overview of National Rulebook – Part III, Article 2 (pages 16 & 17)**

- a. League is responsible for establishing and enforcing boundaries.
- b. Boundaries must be set by a defined, readily recognized format (i.e. town limits, school districts, streets, etc.)
- c. Players playing outside of primary boundaries without proper release, subjects their team to forfeiture of all games played in. A primary boundary is defined as an area where an association has the sole ownership to all participants residing within that boundary.
- d. Waivers must be presented with cause by a parent or legal guardian to both Presidents of the affected associations.
- e. League must approve all waivers between their associations.
- f. Waivers shall only be granted upon written application executed and verified by both League and Association Presidents involved in the waiver request, attesting that the waiver meets one of the “causes” but not limited to, for waiver allowance:
  1. Valid family circumstances in which the child effectively resides in multiple locations.
  2. In cases where the team is full.
  3. In cases where an age/weight team does not exist.
  4. In demonstrated (proven) hardship cases.
- g. All waivers expire annually on December 31<sup>st</sup>.
- h. Only waivers, which serve in the best interest of Pop Warner, will be considered.
